

List of competent authorities designated for the purposes of Regulation (EU) No. 648/2012 on OTC derivatives, central counterparties and trade repositories (EMIR)

Article 22(1) EMIR: " Each Member State shall designate the competent authority responsible for carrying out the duties resulting from this Regulation for the authorisation and supervision of CCPs established in its territory and shall inform the Commission and ESMA thereof. "

Article 10(5) EMIR (on Non-financial counterparties): "Each Member State shall designate an authority responsible for ensuring that the obligation under paragraph 1 is met."
